AFFORDABLE CARE ACT Support Obamacare (ACA) and/or expansion of Medicaid and Medicare?	Yes. <u>Running because Sullivan voted</u> <u>repeatedly to scrap the ACA</u> . Favors offering <u>public option, though not Medicare for all</u> , and focusing more <u>on addressing costs</u> .	No. <u>Supported repeal of the ACA</u> and <u>eliminating the requirement for individuals to</u> <u>enroll in health insurance</u> .
BUDGET CUTBACKS Support Gov. Dunleavy's <u>cutbacks to</u> Marine Highway system, University of <u>Alaska, and other state programs</u> to shift money to Permanent Fund dividend?	No. <u>"Ferries play such an integral role in the</u> way of life in Southeast Alaska, and defunding them threatens the prosperity and health of our coastal communities and villages."	<u>Has declined to comment</u> on specific cuts, like Marine Highway system, but would prioritize the dividend. <u>"One thing I have</u> <u>learned about government is that it will</u> <u>spend every dime you give it, justify it, and</u> <u>ask for more.</u> " Supported including ferry <u>system in federal transportation funding</u> .
<b>CAMPAIGN FINANCE</b> Support <i>Citizens United</i> and unlimited corporate political contributions?	No. <u>"I will fight to end <i>Citizens United</i> and get</u> dark money out of politics."	Yes. <u>Supported</u> <i>Citizens United</i> , while proposing to reject <u>"outside money"</u> in 2014 Senate race.
<b>CLIMATE CHANGE</b> Consider human-caused climate change a serious threat?	Yes. <u>"With a background in science, I know</u> what a serious threat climate change is to the state of Alaska, where we are literally losing villages to the ocean."	Mixed. Unclear <u>if human-caused</u> . Both threat and benefit. <u>"Climate change in Alaska is</u> <u>opening up opportunities": more fishing,</u> <u>commerce and shipping as sea ice recedes</u> . <u>But melting permafrost harms roads</u> .
<b>CLIMATE CHANGE</b> Address as a top priority by limiting output of greenhouse gases?	Yes. <u>"Enormous potential to develop wind,</u> hydroelectric, solar, and tidal power Reducing energy costs in rural Alaska creates <u>new jobs.</u> " Supports <u>re-entering the Paris</u> <u>Climate Agreement</u> . Does support ANWR drilling <u>"in an environmentally safe way.</u> "	No. Against <u>any ban on hydrocarbon</u> <u>production</u> . Asked Trump to pressure financial institutions benefiting from CARES Act to <u>keep "investing in U.S. coal" and oil</u> <u>and gas development</u> . Strong supporter of <u>Arctic National Wildlife Refuge drilling</u> .
<b>CORONAVIRUS</b> Support administration's response to coronavirus?	No. Trump <u>"lost months of preparedness that</u> will be paid for in American lives." <u>"The</u> federal government has failed promoting an <u>organized national response."</u> Also felt <u>Alaska fishermen left out of COVID economic</u> <u>response</u> .	Yes. Praised Trump's COVID task force, though said country needed to "get focused" on more testing. Praises investment in vaccines. On CARES Act, said he fought for inclusion of aid to fishermen.
<b>COURTS – SUPREME COURT</b> Pick Ruth Bader Ginsburg replacement now or let November winner choose? See <u>CEEP Supreme Court guide</u> .	"We both know it is only fair to the American people to wait until they are able to cast their ballots in November."	Trump is "well within his constitutional authority" to nominate someone to fill the U.S. Supreme Court vacancy. In 2016 said "Alaskans deserve to have a voice in that direction through their vote."

<b>ENVIRONMENT</b> Support development of major gold and copper Pebble Mine in Bristol Bay?	No. Early opponent. Calls Pebble Mine <u>"the</u> <u>epicenter of crony capitalism,"</u> the <u>"single</u> <u>greatest threat to our Alaska wild salmon"</u> and <u>an "act of cultural genocide against</u> <u>Alaska Native peoples in Bristol Bay."</u> Alaska Democratic Party has <u>opposed the mine</u> .	Unclear. Has said he would support if adequate permitting process endorsed it. Opposed Obama administration's <u>"preemptive veto of the project,"</u> and <u>supported Trump EPA's repeal of Obama</u> <u>Clean Power Plan, removing a major obstacle</u> . Alaska Republican Party <u>supports the mine</u> .
<b>FINANCIAL REGULATION</b> Tighten or loosen regulation of banks and credit card companies?	No position found.	Loosen. Co-sponsored <u>2019 act</u> to weaken Consumer Financial Protection Bureau.
GUN RULES Enact more restrictive gun legislation?	No. Is pro-gun rights. Opposes assault weapons ban.	No. <u>"Instead of infringing on Americans'</u> <u>constitutional rights, we can work harder to</u> <u>enforce existing laws and keep guns out of the</u> <u>hands of those with mental illness."</u>
IMMIGRATION Path to citizenship for DACA recipients, or "DREAMers" brought to the U.S. as children?	Yes. Will place a priority on protecting DACA recipients.	Mixed. <u>Supported</u> Trump proposal <u>offering</u> <u>DACA recipients path to citizenship in return</u> <u>for major border wall funding and major cuts</u> <u>in legal immigration</u> .
IRAN Prohibit military attacks on Iran without congressional approval? Support Trump's withdrawal from Iran nuclear deal.	No position found on military attacks. Opposed withdrawal from nuclear deal: <u>"Go</u> <u>back to the table with them and negotiate</u> <u>rather than just unilaterally pull out of a pre-</u> <u>arranged agreement."</u>	No on requiring congressional approval for attacks. <u>Voted against February 2020</u> <u>measure</u> that would have required this. Supported withdrawal from <u>"fundamentally</u> <u>flawed"</u> Iran nuclear deal.
LEGAL ABORTION Keep legal or ban?	Legal. <u>"I'll defend a woman's right to choose,</u> and fight attacks on safe, affordable reproductive health care."	Highly restrict. <u>"Life begins at conception and</u> we must fight to protect the lives of the <u>unborn.</u> " Ban abortions after 20 weeks.
LGBTQ RIGHTS Support Gay Marriage and other LGBTQ Rights?	Yes. <u>"As a doctor, I worked for the health and</u> well-being of my patients regardless of their sexual orientation or gender identity. As a senator, I will do the same."	No. Has <u>opposed same sex marriage</u> . <u>Sponsored 2015 act</u> that would prevent government sanctions against contractors whose religious beliefs led them to discriminate against LGTBQ couples.
MINIMUM WAGE Raise federal hourly minimum wage above current \$7.25?	Yes. Says good-paying jobs in Alaska start <u>"by</u> raising the minimum wage and defending collective bargaining rights for our workers and unions."	Unclear. In 2014 changed position to support increasing state minimum wage by \$2 an hour, but said he <u>opposed federal minimum</u> wages. In 2019 <u>opposed</u> \$15-an-hour wage.
<b>PLANNED PARENTHOOD</b> Can Planned Parenthood receive public funds for non-abortion-related care?	Likely yes. <u>Planned Parenthood</u> endorses as someone "who believes health care decisions are between a patient and their doctor."	No. <u>Voted to defund Planned Parenthood</u> in 2015. <u>Has continued to support defunding</u> <u>Planned Parenthood</u> .
SAUDI ARABIA Block arms sales to Saudi Arabia?	No position found.	No. <u>Voted against senate measure to block</u> sale of precision bombs to Saudi Arabia.
<b>STUDENT FINANCIAL AID</b> Support free or subsidized tuition for lower-income individuals?	Likely yes. <u>"I will fight to make college more</u> affordable and accessible for all Alaskans."	No position found.
TAXES Position on Measure 1 to increase taxes on oil production? Supported Trump administration's \$1.9 trillion tax cuts?	Supports Measure 1. No position found on Trump tax cuts.	Opposes Measure 1. <u>Keep the structure of SB</u> 21, which Sullivan helped create as incentive for oil production. <u>Voted yes on Trump tax</u> cuts and Jobs Act.
